4. Purchase the 2017/2018 Insurance Policy with \$5,000 deductible. Now eligible for 25% Pinellas County discount for Flood Controls. \$ \$39,020 budgeted, \$32,145 projected. The motion was duly made by Dave and seconded by Scott. Vote was held . The motion was passed. Unanimous.

6.Approve removing the mango tree behind R to remove the risk of mangos damaging the new roof and removal of invasive carrotwood trees behind building R which are importing over the flood grate for storm sewer. 7. Approve replacement of irrigation pumpand controls. Estimated cost of \$3,500, duly made by Dave and seconded by Jen. Vote was held. The motion was passed.
